NC PERMIT REQUIRED PRIOR TO SCHEDULING EXTRA LESSONS

The Instructor and the Student agree to the following terms and conditions:

- 1.No Certificate of Completion will be issued until all fees are paid.
- 2.This school is licensed by the State of North Carolina, Division of Motor Vehicles.
- 3.This school will not refund any tuition monies or any part thereof when actual services have been rendered.
- 4.Under this agreement an instructor may not provide behind-the-wheel training to more than three individual students
- 5.This agreement constitutes the entire contract between the school and the student, and any verbal assurances or promises not contained herein shall bind neither the school nor the student
- 6.The Instructor will complete the course within a reasonable amount of time: delays caused by mechanical failure, unsafe driving conditions due to adverse weather or any other reason over which it has no control, the Instructor will not be held responsible.
- 7.In the operation of a motor vehicle, there are certain hazards and risks. The Student does hereby specifically assume all such risks as may be incurred in the normal operation of a motor vehicle during course of instruction. Each Instructor vehicle is fully insured with liability coverage in the amount of \$100,000/\$300,000/\$50,000. The Student agrees to completely release the Instructor and its associates from any liability and all claims or courses of action resulting and arising from damages or injuries suffered by the Student during this course to the extent that claims shall not be covered by the Instructor insurance coverage.
- 8.An additional fee of \$25 will apply (once per contract) if a student requests to be picked up at home or other address beyond a reasonable distance from the assigned instructor.
- 9.Dates and times for classroom and in-car instruction will be given to the Student in advance and adhered to. In the event of unforeseen contingencies, the Instructor may make changes as far in advance as possible (no less than 24-hour notice) and all parties notified by telephone or in-person. If the requirement is not met, the 1st time will be a courtesy warning from the instructor. However, the 2nd time it happens, the offending customer will be fined a \$30 cancellation fee. The cancellation fee MUST be paid before the start of the next lesson. There is no fee charged for unavoidable absenteeism or extreme emergency, and the remaining part of the program will be rescheduled between the instructor and the student.
10. Attendance in all classroom sessions is mandatory to fulfill the state requirement of 30 hours of driver education. Virtual class: cameras must be on at all times during virtual sessions, and students are expected to remain engaged throughout the class. Students who miss an entire class (3 hours) will have the option to attend a designated in-person makeup session at the TCDA office after their session ends. The makeup session is offered at a rate of \$25 per hour missed. During the makeup session, students must log in, complete the missed coursework, and take the final exam. Alternatively, students may choose to wait until the next available class to complete the missed session at no additional cost.
- 11.The Instructor cannot and does not guarantee that the Student, upon completion of the course, will successfully pass the examinations given by the Division of Motor Vehicles or that the Student will pass the driving test. The Instructor does agree to exert its best efforts in teaching the Student to meet the requirement of the Division of Motor Vehicles.
